Charles Tillotson:

Good afternoon, we extend a warm Happy 2024 to everyone. In 2024 we will move at the speed of business, maneuver obstacles, execute priorities, and serve our Parish Communities. We have a lot to accomplish this year and we remain steadfast in achieving our goals. Our priority focus is on improving internal and external morale and port processes. Our 2024 goals include:

1. 1st Ouarter

- a. Resetting the 2017 Economic Impact Analysis
- b. Forging ahead with a letter of intent focused on developing a new container port.
- c. Forwarding the Peters Road and Rail Extension engineering design

2. 2nd Quarter

- a. Completing the Master Plan
- b. Port Policy Review and Update
- c. Complete the 2023 Financial Audit

3. 3rd Quarter

- a. Reopen the PALH Ferry Landing
- b. Rebranding the Port to by the 3rd quarter

The culmination of our focus creates a renewed Port and stakeholder Value Proposition. Throughout the year, we will dedicate ourselves to fortifying relationships in the surrounding Parishes and fostering connections with local, state, and federal legislators, as well as governmental and non-governmental offices. Looking ahead to a 2024 strengthened DOTD relationship continuing the progress of the 2027 Ferry Landing design, and the 2028 Electric Diesel Ferry Boat design. We are excited to partner with the RTA on synergizing ferry operations across the region.

Melissa Folse:

We are happy to report that we have executed the PSA for the final remaining parcel in the Piano Keys. This is for the modular home and the land. We are working on refining and improving our internal policies and procedures. This will create a more consistent and cohesive work environment for our office. We have a visit planned to D.C. later this month with a full agenda including meetings with FRA, DOTD, MARAD and our delegation, just to name a few.

Angelina Vicknair:

Our main focus in communications this year will be the rebranding of the Port and community engagement. Our next steps included completing new headshots for the office team and commission, and selection of a marketing firm. We are committed to ensuring the public is informed, and recently secured coverage on WWL regarding the PALH ferry ramp rebuild. This clip can be found on our social channels. The Gazette also published an article regarding the 2024 Outlook for the Port, which has also been shared to our social.

Christie Nielsen:

Human Resources update: Happy New Year! We ended a successful Open Enrollment period where we held 4 separate meetings with the Port staff to review our benefit plans for 2024.

We are looking forward to filling several vacant positions in the Port, especially with the new salary adjustments. We will be advertising for:

- 6 Ferry Deckhand positions
- 3 Chief Ferry Engineer positions
- 4 Ferry Captain III positions (requires a 1600-ton license)
- 1 Marine Diesel Mechanic
- 1 Rescue Captain
- 3 Rescue Engineer positions

We would like to remind you that it is time again to take our Mandatory State required Ethics, Sexual Harassment and Cyber Security trainings for 2024. Yesterday, I emailed the new links sent by the State. Please forward your certificates of completion to the Port HR department as this is an Annual Audit requirement.

WHEREAS, EVALV IT support oversees the timely installation of software updates addressing vulnerabilities and enhancing system performance;

Council Member Edwards offered a Proclamation declaring January 15, 2024, as "Vergie Encalade Day" in the Parish of Plaquemines. The motion received a unanimous second and on roll call, all members present voting "YES", except Council Member Cognevich who was "ABSENT", the Proclamation was adopted by a vote of 8-0.

Council Member Schulz moved to Agenda Item 4, "Update by the Parish President'. Without objection, so ordered. The following was reported by President Hinkley:

- The Administration is still dealing with saltwater issues and dealing with the contracts which will last until February;
- The Boothville-Venice water plant is still under the Saltwater Emergency and the reverse osmosis machine is still running at the facilities;
- The Administration is working on finding funding for permanent osmosis machines at the Venice facility;
- The Hwy. 11 plans are 95% complete. Once the plans are finished, the project can go out for bid;
- PPG was overlooked for the lift station grant; however, they are hoping to start road repairs;
- PPG is anticipating bad weather and calls with GOHSEP have been made; Updates will be provided if needed; and
- Residents in Ironton who have trailers provided by GOHSEP will receive phone calls from the State. President Hinkley asked that if they call you to please answer their questions. They are not kicking anyone out of the trailers.

Council Member Schulz moved to Item 4a, "Update by Charter Directors". Without objection, so ordered.

Director Crystal Taylor informed the public that applications are being taken by Community Action for residents who need assistance with their bills. There are food distributions being done at the Percy Griffin Center on January 16th and also at Davant on the 16th also from 1-3 p.m. On the westbank distributions will be on January 17th from 10 a.m. to 3 p.m. and at the Port Sulphur YMCA on the 18th from 1-3 p.m. On the 19th it will be at Boothville/Venice. Beginning on February 3rd, Family Services will be in building 100 of the Belle Chasse Government Complex. She further stated that Civil Service said there is a total of 46 vacancies and to date in 2024 42 have been filled. There has been a loss of 31 employees and open vacancies have been posted. Also, the annual employee compliance training will begin soon.

Director Billy Wichers stated that the hiring process and the raises are working. They have more people applying for jobs with the Parish. He then explained that asphalt road repairs are done in house and they will divide projects up by small, medium and large. They do not do large projects nor do they do concrete repairs. The Engineering department has been on the ball with lining up contracts to get things done. Mr. Wichers explained that the Hwy. 11 repairs will be major projects and there are only four Heavy Equipment Operators; however, whatever they can do in house, they will handle. In addition to all the above listed items, there are still culverts and ditches to be cleaned so all this will not be done overnight.

Director Jeff DiMarco reported that he has an appointment with vendors on Friday to finalize quotes to repair the Parish pools and they will be ready to use during the summer. He is planning to receive the final report on the Port Sulphur Government building next week. Mr. DiMarco said the EMS Department is his priority right now. A contract will be signed with Nunez Community College to have their students do field work with PPG's EMS department and he hopes to have some recruitment of the students.

WHEREAS, the objective of the proposed Bay Adams Ridge Restoration and Marsh Creation (BA-0272) project is to engineer and design a natural land bridge that will reduce storm induced wave conditions on the West Bank of the hurricane protection system and the estuarine marshes behind it. PPG will seek to design a series of elevated vegetative ridges that complements the current levee system and to recreate marsh where open water now exists. The proposed project will restore approximately 6.2 miles of natural headland ridge and create approximately 816 acres of new marsh; and

WHEREAS, the Project is an integrated coastal protection project eligible for funding under Section 105 the Gulf of Mexico Energy Security Act (GOMESA) Act of 2006 (Title I of Division C of Public Law 109-432; 43 U.S.C. 1331 *et seq.*; 120 Stat. 3000), 30 C.F.R.
