- 6i, "An Ordinance to create the Legal Department and the position of Executive Counsel of the Plaquemine Port, Harbor and Terminal District; to amend the 2021 General Fund, Manpower Structure and Operating Expenditure Budget to provide for the Legal Department; and otherwise to provide with respect thereto. Commissioner LaFrance joined the meeting at 3:03 p.m.

There being no matters to address under the following Agenda Item 2, "Executive Session", Commissioner Blink moved to Agenda Item 3, "Status Report by the Executive Port Director". Without objection, so ordered. The following topics were addressed by Sandy Sanders:

- Budget Review meetings were held for the Commissioners;
- A management database for those wanting to compete for available jobs has been created with the understanding that locals will be the first considered for those jobs;
- There is continued work being done with UNO to update the Port Tariff;
- Many meetings have been held with PPG regarding the transfer of the Ferries to the Port;
- Stakeholder meetings continue for all parties associated with the Container Port. The design team will be at the next Port meeting to provide a report to the Commissioners;
- The Mississippi River Ship Channel Deepening project is moving forward;
- DOTD appears to be placing the Water Booster Station project in its Priority Program; and
- Paul Matthews was chosen to be the Executive Director of the Port of South Louisiana and he starts that job next year.

Commissioner Blink moved to Agenda Item 7, "New Business". Without objection, so ordered.

Sandy Sanders arranged for several individuals to report on various port projects. The following people were present to report on the following projects:

- PLT: Tallgrass could not attend the meeting; however, they will be at the first meeting in January 2022.

Agenda Item 7b, "PLT discussion and update" was addressed under the review of projects above.

Under Item 7c, "Insurance presentation and update by Mr. Verdin", Ms. Addie Liebel addressed the Commissioners about the progress made stating no final numbers were received but there has been a \$68,000 decrease in the numbers.

There being no matters under Agenda 3a, "Financial Report/Budget to Actual" and no "Bids and Advertisements", Commissioner Blink moved to Agenda Item 5, "Introduction of Ordinances and Resolutions". Without objection, so ordered. The following legislation was introduced:

- 4. A Resolution authorizing the Executive Director, Maynard "Sandy" Sanders, enter into an agreement with Mercury Public Affairs to provide consulting, advisory, and lobbying services regarding Port representation at the Federal and Regional level for a one-year term; and otherwise to provide with respect thereto. COMMISSIONER NEWBERRY

An Ordinance to amend and as amended readopt Ordinance No. 07-102, adopted May 10, 2007, to establish and initiate the collection of the Plaquemines Parish Port, Harbor & Terminal District Security Fees (Security Surcharges); and otherwise to provide with respect thereto.

WHEREAS Ordinance No. 07-102 was adopted by the Plaquemines Parish Council as the sole governing authority of the Plaquemines Parish Port, Harbor & Terminal District enabling the collection of Security Fees (Security Surcharges); and

WHEREAS, the Plaquemines Parish Port, Harbor & Terminal District is a member of the Gulf Seaports Marine Terminal Conference; and

WHEREAS, by a vote of the membership of the Gulf Seaports Marine Terminal Conference, of which the Plaquemines Parish Port, Harbor & Terminal District is a member, increasing Security Fees (Security Surcharges), effective January 1, 2022; and

WHEREAS the Security Surcharge will be assessed against vessels and barges as a percentage of total dockage charged, and as a tonnage fee against cargo, with the exception of containers which, will be assessed on a per unit basis. The Security Surcharges will be assessed in addition to all other fees which may be due under this tariff as follows:

Vessels and barges, 10.41 percent (10.41%) of total dockage assessed per Port call; Cargo (to be billed to the party paying dockage)

Break Bulk \$0.22 per ton (212cents/ton)
Dry Bulk \$0.049 per ton (4.9 cents/ton)
Liquid Bulk \$0.049 per ton (4.9 cents/ton)

Containers \$4.60 per box (4 dollars sixty cents/box)

Vehicles \$1.03 per vehicle (1 dollar 3 cents/vehicle)

Passengers \$1.03 per passenger (1 dollar 3 cents/passenger)

### NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR & TERMINAL DISTRICT THAT:

## **SECTION 1**

In addition to all other fees, charges and tariffs previously passed by the Plaquemines Parish Council and the Plaquemines Parish Port, Harbor & Terminal District, the following Security Fees (Security Surcharges), as to be described in this tariff item, in accordance with the notice filed with the Federal Maritime Commission by the Gulf Seaports Marine Terminal Conference shall be assessed against all vessels, barges and cargo interests using services or facilities of the Plaquemines Parish Port, Harbor & Terminal District as a percentage of total dockage charged, and as a tonnage fee against cargo, with the exception of containers, which will be assessed on a per unit basis as follows:

Vessels and Barges -10.41 percent (10.41%) total dockage assessed per Port call; cargo (to be billed to the party paying dockage)

Break Bulk \$0.22 per ton (22 cents/ton)
Dry Bulk \$0.049 per ton (4.9 cents/ton)
Liquid Bulk \$0.049 per ton (4.9 cents/ton)

Containers \$4.60per box (4 dollars sixty cents/box)

Vehicles \$1.03 per vehicle (1 dollar 3 cents/vehicle)

Passengers \$1.03 per passenger (1 dollar 3 cents/passenger

WHEREAS, there will be a significant benefit to the people, businesses and commerce of Plaquemines Parish if the Port were to enter in a Cooperative Endeavor Agreement to transfer certain rights, obligations, liabilities, and assets related to ferry services from Plaquemines Parish Government to the Plaquemines Port, Harbor and Terminal District; and

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL, AS THE SOLE GOVERNING AUTHORITY FOR THE PLAQUEMINES PORT, HARBOR AND TERMINAL DISTRICT THAT:

## **SECTION 1**

It hereby authorizes and directs Port Executive Director, Maynard J. Sanders, to enter into a Cooperative Endeavor Agreement, attached hereto as Exhibit A, with the Plaquemines Parish Government for the transfer of certain rights, obligations, liabilities, and assets related to ferry services.

### **SECTION 2**

It hereby establishes a Ferry Department within the Plaquemines Parish Port, Harbor and Terminal District.

### **SECTION 3**

It hereby accepts the transfer of the Plaquemines Parish Ferry Department employees to the Plaquemines Parish Port, Harbor and Terminal District, all in accordance with Civil Service Rules. Said transfer shall become effective on January 1, 2022.

#### **SECTION 4**

WHEREAS, the Plaquemines Port, Harbor and Terminal District was created as a public corporation and political subdivision of the State of Louisiana and was ratified and approved as a port, harbor and terminal district pursuant to Section 31 of Article XIV of the Constitution of the State of Louisiana for the year 1921, and whose powers and authority are further defined in La. R.S. 34:1351, *et seq*; and

WHEREAS, CHS, founded in 1929, is a diversified global agribusiness cooperative owned by farmers and local cooperatives across the United States, and who employs more than 10,000 dedicated people around the globe who provide customers with a strong, efficient supply chain, access to global markets, and products and services for agricultural businesses and rural communities; and

WHEREAS, Article VII, §14(c) of the Louisiana Constitution of 1974 and La. R.S. 33:9031 provide that, for a public purpose, political subdivisions of the State may, such as the Port, can engage in agreements with any private association, corporation or individual; and

WHEREAS, CHS has informed the Port that it plans to develop (in the first phase of this project) an approximate \$36.5 million industrial development project on approximately 30 acres of undeveloped or underdeveloped property owned by CHS (as further defined below, the "Property"). CHS will construct on the Property a new dock and barge unloading system and an independent conveyance for barge unloading (as further defined below, the "Project"). The Project will expand the facility export capability by approximately 30%. This equates roughly to an additional 1,200 barges unloaded and 46 vessels loaded per year. The increase in capacity – 2,540,000 metric tons of product – results in an estimated \$1 billion in additional U.S. agricultural products will move through the Project for international markets; and

WHEREAS, as objectively provided for in Appendix G of the PIDP Grant Application, the Project is estimated to generate a net present value of all economic, environmental and safety benefits is \$264,872,000 over a twenty-year period. The project is anticipated to generate 80 construction jobs, 4 terminal jobs and anticipated 176 indirect jobs as a result of the first two phases of the planned expansion project; and

WHEREAS, the Port is a bulk port, coextensive with Plaquemines Parish, located at the mouth of the Mississippi River in Plaquemines Parish, Louisiana. Its strategic location provides water access to 33 states. The port is ideally located to serve expanding global markets for oil & gas, grain, coal, and chemicals; and

WHEREAS, during the course of this Agreement, the Property shall be required to be solely used for maritime commerce that directly benefits the Port in terms of direct and indirect revenues; and

WHEREAS, on July 30, 2021, the Port submitted an application to the U.S. Department of Transportation for MARAD's Port Infrastructure Development Program Grant ("PIDP Grant Application"); and

WHEREAS, the PIDP Grant Application requests \$21,879,673 for the Project; and

WHEREAS, the PIDP Grant Application requires CHS to make an initial investment of \$14,586,449 and to deliver the Project; and

WHEREAS, the Project will be owned by the Port during the duration of the term of this Agreement, at which time the Project will be transferred from CHS to the Port under La. R.S. 33:4712.2; and

WHEREAS, La. R.S. 33:4712.2 authorizes the Port to transfer property for industrial inducement purposes to CHS, by suitable and appropriate contract. This statute authorizes the Port, in determining the consideration for this transfer, to consider the potential value of the public economic impact of the enterprise being induced to locate within or adjoining the Port; and

WHEREAS, the Port has evaluated the potential risks and rewards for the Port's participation and investment in the Project and has determined that under this Agreement and the other Transaction Documents, along with the Public Benefit Economist Report attached hereto, the Port reasonably expects the public economic impact to be more than equivalent value and benefit for the transfer of the Property to CHS for an industrial inducement purpose;

## NOW, THEREFORE:

## **SECTION 1**

The signatures of the said officers upon documents specifically described herein together with any documents and certificates as may be otherwise required for necessary, convenient, appropriate or desirable related to matters described in this resolution, are deemed to be conclusive evidence of their due exercise of the authority vested in them hereunder.

## **SECTION 3**

<u>Authorization</u>. The Chairman, Vice-Chairman and President/CEO of the Plaquemines Port, Harbor and Terminal District, or any one of them, upon the advice of counsel, shall each be further authorized to negotiate, execute and deliver any future servitudes, easements, mortgages, rights-of-way, releases, conveyances or other instruments with respect to the Property described in the CEA, or such additions thereto, as may be required by or provided for in the CEA, or as may be requested by the CHS, or as may otherwise be required for or necessary, convenient or appropriate to the Project, the payments described in the CEA, and which have been reviewed and approved by the Plaquemines Port, Harbor and Terminal District's special counsel.

Effective Date. This resolution shall take effect immediately.

WHEREAS, the Port is the owner of a 276.6 acre parcel in Plaquemines Parish known as Tract DR-2A1, as shown on the Map of Resubdivision, Tract DR-2A into Tracts DR-2A1 and DR-2A2, Property of Woodland Borrow Pits, LLC, by Hugh McCurdy, III, P.L.S., dated January 28, 2016, as amended, a copy of which is annexed and made part hereof; and

WHEREAS, the Port seeks to have Tract DR-2A1 designated as a magnet site for FTZ usage, which would allow qualified businesses to take advantage of FTZ incentives and cost-savings benefits within the magnet site upon activation with U.S. Customs and Border Patrol;

### NOW, THEREFORE:
