Charles Tillotson, Melissa Folse, Angelina Vicknair, Jalen Brown and Christie Nielsen were present representing the Port.

The Prayer and Pledge was dispensed with .

The following items were deferred:

- 6b, "An Ordinance to amend the Five-Year Capital Improvements Plan, Pointe-ala-Hache Ferry Ramp Repair Project; and otherwise, to provide with respect thereto"; and
- 6c, "A Resolution authorizing and directing the Port Chairman, Brian Champagne, to extend the employment contract of Melissa Folse as Deputy Port Director/Executive Counsel; and otherwise to provide with respect thereto.

There being no matters for Executive Session, Commissioner Champagne moved to Agenda Item 3, "Status Report by the Executive Port Director. Without objection, so ordered. Mr. Tillotson reported the following:

- The Port continues to move along with the projects they have been working on such as the PALH ferry landing emergency repairs, the Port Master Plan, the development of the container terminal milestone and Port Policy;
- Mr. Tillotson informed everyone that there was a smooth transition to the new payroll system;
- On Tuesday, the Port executed a joint CEA with Jefferson Parish and the City of Gretna. The Port approved an additional \$1.5 million of funds for the Peters Road By-Pass. The City of Gretna is executing an agreement with the contracting firm CSRS. This is a monumental piece of progress because it is the initiation of the first 30% engineering and planning design of Peters Road;
- A full Master Plan review was done with the Bridges group. The Port and the Bridges group went over everything that has been completed to date and what will be done in the future. On May 17<sup>th</sup> there will be a meeting to review the plan with the Council Member and the Port is looking forward to input from each individual Council Member. Currently the Port is on task to complete the plan on May 31<sup>st</sup>;
- There is continued progress in Baton Rouge with the assistance of David Vitter. SB Bill 685 was heard and it was deferred; and
- In regard to the PALH emergency repairs, the Port received preliminary results on the slope analysis. Mr. Tillotson is prepared to create a timeline of events from the start to where they are today, as well as a projection of what they need to do. The findings were less than favorable for the Port because the CORPS required 1.3 safety factor for the levees to make the repairs that were planned. This has put the Port in a position where the scope of the RFP has to be changed and so does the dollar amount. They will need to rebid the contract.

There was no report provided under Agenda Item 3a, "Financial Report/Budget to Actual" and there were no matters under Agenda Item 4, "Bids and Advertisements". Therefore, Commissioner Champagne moved to Agenda Item 5, "Introduction of Ordinances and Resolutions". Without objection, so ordered. The following legislation was introduced:

Kent, Sr. Divisions and Lot V-1, Vidrine Division located at 8056 Highway 23 Belle Chasse, LA (Popich Building and property) and Lots V-2 and V-3, Vidrine Division (currently parking lots adjacent to the Popich Building) Belle Chasse, LA for its own public purposes;

WHEREAS, Plaquemines Parish Government obtained an appraisal through RRL Real Estate Appraisal, LLC dated August 30, 2023, for both properties, and the fair market value of each was determined to be the following:

For Lots A-1, R.C. Kent, Sr. Divisions, and Lot V-1, Vidrine Division located at 8056 Highway 23 Belle Chasse, LA (Popich Building and property), the Fair Market Value was determined to be \$2,600,000.

For Lots V-2 and V-3, Vidrine Division (currently parking lots adjacent to the Popich Building), the Fair Market Value was determined to be \$129,590.00;

The combined fair market value of both properties was determined to be \$2,729,590.00 from the appraisal obtained by the Plaquemines Parish Government;

WHEREAS, Plaquemines Port Harbor & Terminal District obtained an appraisal through Stegall, Benton, Melancon & Associates dated December 18, 2023, for both properties and the fair market value of each was determined to be the following:

For Lots A-1, R.C. Kent, Sr. Divisions, and Lot V-1, Vidrine Division located at 8056 Highway 23 Belle Chasse, LA (Popich Building and property), the Fair Market Value was determined to be \$1,800,000.

For Lots V-2 and V-3, Vidrine Division (currently parking lots adjacent to the Popich Building), the Fair Market Value was determined to be \$75,000;

The combined fair market value of both properties was determined to be \$1,875,000.00 from the appraisal obtained by Plaquemines Port Harbor & Terminal District;

WHEREAS, based on standard policy a second appraisal was sought by the Port through Bird & Associates dated February 28, 2024, for both the building and the adjacent lots, and the fair market value of each was determined to be the following:

For Lots A-1, R.C. Kent, Sr. Divisions, and Lot V-1, Vidrine Division located at 8056 Highway 23 Belle Chasse, LA (Popich Building and property), the Fair Market Value was determined to be \$1,875,000.

For Lots V-2 and V-3, Vidrine Division (currently parking lots adjacent to the Popich Building), the Fair Market Value was determined to be \$90,000 the combined fair market value of both properties was determined to be \$1,965,000.00 from the appraisal obtained by Plaquemines Port Harbor & Terminal District;

WHEREAS, the Parish and the Port have mutually agreed to base the purchase price of the Popich Building and adjacent lots on the average of the three appraisals, \$2,189,000;

WHEREAS, following the completion of the Port's appraisal, the Plaquemines Parish Government will enter into a mutually agreed upon Purchase and Sale Agreement;

WHEREAS, the funds for the purchase of the Popich Building will be disbursed from the Unrestricted Fund Balance;

WHEREAS, any current or future lease agreements within the building will transfer at the time of sale from the Plaquemines Parish Government to Plaquemines Port Harbor & Terminal District;
