Sandy Sanders, Paul Matthews, and Chambrel Riley were present to represent the Port.

The Prayer said and the Pledge was recited.

Agenda Item 6b, "A Resolution authorizing Maynard "Sandy" Sanders, as Executive Director of the Plaquemines Port, Harbor & Terminal District, to extend the agreement with Trident Holdings, Inc., for the implementation of the Port's Master Plan; and otherwise to provide with respect thereto" was withdrawn.

There being no Executive Session, Commissioner Blink moved to Agenda Item 3, "Status report by the Executive Port Director". Without objection, so ordered. The following was reported by Sandy Sanders:

- An update was received from the USACE regarding parcel B-3. This is the last request in order to deliver to Venture Global all of their contractual requests of the Port. The Port has been diligently working with the 408 permit staff to achieve the safety factor of 1.3 in regards to the levees. The team is reworking the layout in order to achieve this safety factor and it should be accomplished soon;
- The Port has been informed that 26 of the Port's Fire Protection Officers have been approved for the State supplemental pay which became effective as of July 1, 2020. Special thanks to Donald Durr who worked hard to get this pay for said Port employees;
- The Port has coordinated and completed the annual certification of the State mandated Ethics training for all Port Employees; and
- The Port continues to oversee and maintain Port office computers, servers, internet and website with Port IT firm in order to allow for a seamless workflow. Everyone is doing their part to ensure Port business continues during this pandemic. The health and safety of the Port employees remains the number one priority; and
- Beginning with this meeting, Mr. Sanders will have a Ship Call summary and comparison from year to year measured with a vessel remaining in their jurisdiction for a minimum of 12 hours. In April of this year the numbers were up from April 2019 by 4 vessels for a 2020 total of 274 and in May of this year the numbers were up from May 2019 by 1 vessel for a 2020 total of 234.

Commissioner Cognevich said Mr. Helmers told him there is a boat the Port does not use anymore and he would like to use it. Sandy Sanders said he would check on this and let Commissioner Cognevich know.

Commissioner Rousselle said he noticed on their calendar there was a BUDMAT meeting and asked for an update; however, Sanders said they did not have that meeting. They are typically noticed on their calendar twice a month and they try to have both of those meetings but they did not today. He did say that the engineer attends the meetings and reports back to the Port. Commissioner Rousselle asked for the update provided by the Engineer and was told by Sandy Sanders that he does not have a report yet but could give update from his last report. He stated they are making progress and has a verbal green light from CPRA regarding the money match. As soon as COVID is over Sandy Sanders and John Helmers plan to meet the CPRA face to face and

get that codified. Commissioner Blink stated currently there is surveying taking place right now for the beneficial use.

Under Item 3b, "Financial Report/Budget to Actual", Chambrel Riley reported there was nothing significant to report and she asked that the Budget to Actual be removed from the agenda for the first Port meeting of each month, as she will only provide this report once a month.

Tracy Riley addressed the Council in regard to the video of the June 25, 2020, Port meeting and was very concerned about reconciling some expenditures because her name was brought up in regard to a lunch in January 2020. Council Member Rousselle had some questions about contractors having access and conversations in regard to upcoming solicitations. Mrs. Riley explained, that when John Bel Edwards came to Plaquemines to announce the LNG project in Plaquemines Parish, the opportunity for Parish residents to work on these types of projects was a priority. As a member of this community and as a member of a black owned business, she was eager to participate in Port business. She corresponded with the Port by email, phone calls and visits to inform the Port of her interest. Mrs. Riley went on to say that during the June 25<sup>th</sup> meeting it was implied that nefarious conversations were made or benefits were being provided to the Collaborative and/or Tracy Riley. She stated for the record that this is not true and she is simply attempting to work with the Council and the Port so we can have economic opportunities.

Donald Vallee addressed the Council explaining that several meetings ago he had questions regarding the Port Budget. Sandy Sanders made a point to meet with him to answer those questions. They went through the budget, line item by line item, some information was not very clear and he is still waiting on some documentation from Chambrel Riley. Mr. Vallee made some recommendations to the Council regarding the Port such as how to give updates to the Council and the public, as well as the frequency of those updates, and placing a freeze on salaries, hiring and expenditures. Mr. Vallee believes more in-depth policies should be created. He suggested Sandy Sanders should provide a 12 month summary of what is going on with the Port and a schedule for when contracts are coming due should be provided to the Council. Mr. Vallee further stated that the Port was very receptive to his comments and he wants to see the Parish and Port benefit and survive.

There being no Bids or Advertisements, Commissioner Blink moved to Item 5, "Introduction of Ordinances and Resolutions". Without objection, so ordered. The following items were introduced:

The Prayer and Pledge of Allegiance were dispensed with.

President Lepine was absent; however, the three Charter Directors, Todd Eppley, Crystal Taylor and Scott Rousselle were present representing the Administration.

The following items were deferred:

- 9a(1), "An Ordinance pursuant to Article III, Plaquemines Parish Boat Harbors, Section 6-41, to set fees for lifting, blocking, storage and stationary lifts at the Empire, Venice and Pointe ala Hache Shipyards; and otherwise to provide with respect thereto" was deferred for the fourth time; therefore, it fell off the agenda;
- 9a(2), "An Ordinance to rescind, annul and set aside Ordinance No. 403, adopted December 8, 1982; rescind, annul and set aside Section 6 and Section 7 of Ordinance No. 40, adopted April 9, 1964; establish Article IX to be titled "Mosquito Control" of Chapter 13 of the Parish Code of Ordinances; establish a user fee for Mosquito Control in order to continue to abate, control, eradicate, and study mosquitoes and other arthropods of public health importance and all activities incidental thereto; and otherwise to provide with respect thereto" was deferred for the fourth time; therefore, it fell off the agenda;

- 9a(3), "An Ordinance approving a plan of resubdivision of a portion of Tract 5-E, Belle Chasse Plantation, Plaquemines Parish, Louisiana, as shown on the plat of survey of Cypress Park Subdivision, Phase 1B, by Bryant Hammett and Associates, certified by Hugh McCurdy, III, P.L.S., dated April 28, 2020, the owner having fulfilled all the requirements of the Subdivision and Resubdivision Ordinance of the Parish of Plaquemines without cost to the Plaquemines Parish Government or the Parish of Plaquemines; and otherwise to provide with respect thereto":

There being no Executive Session or Proclamations, Council Member LaFrance moved to Agenda Item 4, "Status Report by the Parish President". Without objection, so ordered. In President Lepine's absence, Director of Adminisation, Crystal Taylor, stated that all questions on the agenda have been addressed via emails sent by the Directors to the Council and they are ready to answer any questions. Council Member Rousselle stated that the reason why these items are on the agenda are because residents have the questions. The following was addressed:

- In regard to the broken gas line in Ranazta's Trailer Park, Crystal Taylor stated that the gas line has been repaired. When asked by Council Member Rousselle if the Parish has any liability for the gas line, Director Todd Eppley said he does not feel they have any liability and Parish Attorney, Rennie Buras, said he could not speculate on the liability at this time because he does not know all the facts.
- Under the Corona Virus update, the Council was told that according to the Governor Stage 2 will likely last until mid-July. The Administration was asked if President Lepine intends on implementing any new restrictions and/or to mandate masks in public and the response was no, he is following the Governor's guidelines. When questioned as to if there were any hotspots in the Parish and if the Administration was informed about the outbreak at Daybrook Fisheries, the Council was told there were no hot spots and they were informed of the outbreak. Council Member LaFrance asked for a weekly report on this matter from the Administration.
- The following questions were answered in regard to the Pointe-a-la-Hache ferry:
  - 1) What are the current operational hours of the ferry? Monday, Thursday and Saturdays from 6:00 a.m. to 7:45 p.m. and the remainder of the days from 6:00 a.m. to 7:45 a.m. and again from 6:00 p.m. to 7:45 p.m.
  - 2) What were the operational hours prior to March 2020? Monday through Sunday from 6:00 a.m. to 9:30 p.m.
  - 3) Why did the Administration change the operational hours? To limit the ferry crew's exposure during the stay at home order. A lengthy discussion was held between the Administration, the Council and members of the public as to why the Belle Chasse ferry's hours were cut and the need for legislation to set the hours.
  - 4) During the days on which the Pointe-a-la-Hache Ferry operates a limited schedule, are the crew members of the ferry paid during the hours in which the ferry is not making regular trips across the River? Director Todd Eppley said they are getting paid but, he does not know superficially what is being done. He does know each employee on the crew has assigned tasks. Council Member Barthelemy said he went to the PALH ferry several days a week and he would not see anyone working but would see employees sitting on the levee. He feels like we were paying people not to work and it worries him because of the financial crisis the Parish is having.
  - 5) How much money has been saved by the changing in hours during which the ferry makes trips across the River? Approximately \$60,000 saved since March in overtime which is

- 100 hours per week and about \$1200 a week savings in fuel. Discussions were held regarding the financial crisis, ferry fees, the need for the PALH ferry and the inconvenience of it not running at the regular schedule.
- 6) How many round-trips did Pointe-a-la-Hache Ferry make in each of the following months: January, February, and June of 2020? January: 2,097 because the Belle Chasse was out of service, February: 1,740 the Belle Chasse was out of service for part of the month, June: 918 when abbreviated schedule was in place.
- Under the update on Sales Tax collection Council Member Rousselle said the Council Members received an email with the Sales Tax and Use Tax report from Finance. Estimates are on the sheet and there is still a deficit on those collections at 26%. The estimate for the rest of the year is at a 25%, 15% and 10% deficit. He thought things were looking better because in May sales tax was up 6.9% but, in June it was down 26.41% and also down in July by 27.73%. Hopefully sales tax will come back

Council Member Barthelemy asked to seek a suspension to the rules to add an item for consideration at today's meeting entitled, "An Ordinance authorizing and directing the Parish President, or his designee, to have the Pointe-a-la-Hache Ferry run Monday through Sunday from 6:00 a.m. to 8:00 p.m.; and otherwise to provide with respect thereto". The motion was offered by Council Member Barthelemy, seconded by Council Member Cognevich and on roll call all members present voting "YES", except Council Members Black and Arbourgh who "ABSTAINED" and Council Member Guey being "ABSENT", the motion failed by a vote of 6-2.

Council Member LaFrance reverted back to the President's update:

- Under the update on oil and gas revenue collections, Council Member Rousselle said the Parish is three months behind on collections. For April/May the collections were down 13.6%, for May/June down 65.75% but, June/July collections were up 39.89% above the estimate. Hopefully we will continue to see increases in collections above the estimate. The State royalty collections were down 21% in January, down in February 20%, down in March 11% and down in April and May 56%. The projection for the rest of the year is down 50-73% but, hopefully it will not be that bad.
- In regard to the report on amount of time the Ferry was out of service, as previously requested. Council Member Rousselle said enough time had been spent on the ferry.
- Under the status and update on the Medal of Honor Park drainage pump, Council Member Rousselle explained that he was informed by Director Scott Rousselle that they are searching for quotes and in the meantime, they are looking at the engine.
- Discussion and recommendation by the Administration on the C&C Marine ITEP Application No. 2019203-ITE, Council Member Rousselle stated the ITEP application had been received and he wanted to discuss this matter with the Administration. He explained that the Council has until the next meeting to take action and then another 30 days after that. Council Member Rousselle asked if the Administration has taken a position on application. Keith Espadron said they only received the application two days ago and he has not met with Assessor or C&C Marine, so the Administration has no recommendation at this time. Council Member Rousselle said he would introduce legislation to either approve or deny the application later in this meeting.

Council Member LaFrance moved to Agenda Item 9q.

WHEREAS, Packard Truck Lines, LLC, has been diligently working with state and local governments, as well as with the New Orleans & Gulf Coast Railroad, to replace the switch and get the rail reactivated and has recently finalized a new contract regarding the rail spur; and

WHEREAS, Packard is already in negotiations with the Port of New Orleans to stage and store material required for Plaquemines LNG, has already been approved by Venture Global as a vendor in anticipation of Plaquemines Port development, has opened a Foreign Trade Zone and has a full pipe inspection facility in its yard; and

WHEREAS, the Plaquemines Parish Council believes the reactivated rail line will be a huge economic benefit on both the local and state level; and

WHEREAS, Packard's efforts will provide an increase of jobs in the Plaquemines Parish and an increase in the amount of taxes collected by the Parish; and

WHEREAS, it is the desire of this Council to stress its opposition to the removal of Railroad Spur Track Crossing DOT No. 855644P and to urge Governor John Bel Edwards, the Plaquemines Parish State Legislative Delegation and the Louisiana Department of Transportation and Development not to remove the spur;

## NOW, THEREFORE:

BE IT RESOLVED BY THE PLAQUEMINES PARISH COUNCIL THAT it opposes the removal of Railroad Spur Track Crossing DOT No. 855644P and urges Governor John Bel Edwards, the Plaquemines Parish State Legislative Delegation and the LA Department of Transportation and Development not to remove the railroad spur.

Parish Attorney, Rennie Buras, said he will get in touch with Mr. Clarence Brocks and set up a meeting regarding the CEA.

An Ordinance by the Plaquemines Parish Council, as and on behalf of the West Bank Levee District and Buras Levee District, to appropriate new Perpetual Flood Protection Levee, Floodwall and Drainage Ditch Easements in certain portions of lands in Plaquemines Parish, Louisiana to construct the New Orleans to Venice (NOV), West Bank Hurricane Protection Levee Project NOV-09, St. Jude to City Price, Plaquemines Parish, Louisiana for levee, floodwall, drainage, flood, access and hurricane protection purposes; and otherwise to provide with respect thereto.

WHEREAS, the U. S. Army Corps of Engineers has determined that certain lands situated in Plaquemines Parish are required to construct the New Orleans to Venice, West Bank Hurricane Protection Levee Project NOV-09, St. Jude to City Price, in Plaquemines Parish, Louisiana, hereinafter referred to as "the NOV-09 Project"; and

WHEREAS, land rights were previously acquired for the NOV-09 Project pursuant to prior Ordinance No. 18-93, adopted on July 26, 2018; and

WHEREAS, additional rights of way are required for the NOV-09 Project to shift the reach four levee centerline 25 feet landside to avoid removing a section of buried concrete slope paving, which revisions to the layout of the levee include shifting and extending a drainage ditch 10 feet from the levee toe; and

WHEREAS, the land estates required to construct the NOV-09 Project are identified in right-of-way drawings entitled "West Bank Mississippi River Levee, New Orleans to Venice, NOV-09, St. Jude to City Price, Plaquemines Parish, Louisiana," File Number H-8-47471, Sheet Identification Numbers G-001 through G-003 (general information), CU-101 through CU-103 (civil drawings), CU-401 (utility/facility dispositions) and RR-101 through RR-104, and RR-601 thought RR-604 (real estate drawings) dated June 7, 2018, revised February 3, 2020 hereinafter referred to as "NOV-09 Right-of-Way Drawings" attached hereto and made part hereof as Exhibit A; and

WHEREAS, the "Perpetual Flood Protection Levee, Floodwall and Drainage Ditch Easement" is a perpetual and assignable right and easement in (the land depicted in Exhibit A) (Various Tracts) to construct, maintain, repair, operate, patrol and replace a flood protection levee, floodwall, and drainage ditch, including all appurtenances thereto together with the right to trim, cut, fell and remove therefrom all trees, underbrush, obstructions and other vegetation, structures, or obstacles within the limits of the rights-of-way; reserving, however, to the owners, their heirs and assigns, all such rights and privileges in the land as may be used without interfering with or abridging the

rights and easement hereby acquired; subject, however, to existing easements for public roads and highways, public utilities, railroads, and pipelines; and

WHEREAS, the constitution and laws of the State of Louisiana law provide that levee districts are authorized to appropriate needed lands for levee, drainage, flood and hurricane protection purposes; and

WHEREAS, by letters dated June 6, 2018 and May 22, 2018, addressed to Amos Cormier, as President of the Plaquemines Parish Government, the U. S. Army Corps of Engineers referenced its letter dated February 13, 2017 in which it provided notification of rights-of-way requirements in advance of environmental clearance and officially requested that Plaquemines Parish Government grant to the United States of America a clear and unobstructed right of entry, including the right of ingress and egress, to construct the aforementioned NOV-09 Project; and

WHEREAS, copies of the aforementioned letters are attached hereto and made part hereof as Exhibit B; and

WHEREAS, by letter dated May 11, 2020, addressed to Kirk Lepine, as President of the Plaquemines Parish Government, U.S. Army Corps of Engineers officially requested additional rights of way for a Perpetual Flood Protection Levee, Floodwall and Drainage Ditch Easement to shift and extend the centerline of a portion of the levee as shown on the aforementioned NOV-09 Right-of-Way Drawings; and

WHEREAS, a copy of the aforementioned letter is attached hereto and made part hereof as Exhibit C; and

WHEREAS, in order to provide the U. S. Army Corps of Engineers the requested right of entry for the subject project, it is incumbent upon and the responsibility of the Plaquemines Parish Council, as and on behalf of the West Bank Levee District and Buras Levee District, to appropriate new Perpetual Flood Protection Levee, Floodwall, and Drainage Ditch Easements all in Plaquemines Parish as identified in the aforementioned NOV-09 Right-of-Way Drawings for levee, floodwall, drainage, flood and hurricane protection purposes;

NOW, THEREFORE:

BE IT ORDAINED BY PLAQUEMINES PARISH COUNCIL THAT:

### SECTION 1

As and on behalf of the West Bank Levee District and Buras Levee District, that it finds that the appropriation of new Perpetual Flood Protection Levee, Floodwall, and Drainage Ditch Easements all in Plaquemines Parish as identified in the NOV-09 Right-of-Way Drawings attached as Exhibit A are necessary, useful and required by the West Bank Levee District and Buras Levee District for drainage, levee, floodwall, flood and hurricane protection purposes and are required for the construction of the NOV-09 Project.

# SECTION 2

As and on behalf of the West Bank Levee District and Buras Levee District, it does pursuant to the constitution and laws of the State of Louisiana hereby appropriate new Perpetual Flood Protection Levee, Floodwall, and Drainage Ditch Easements all in Plaquemines Parish to construct the NOV-09 Project for levee, floodwall, drainage, flood and hurricane protection purposes as identified in the NOV-09 Right-of-Way Drawings attached as Exhibit A.

WHEREAS, delays associated with the COVID 19 pandemic have delayed progress on the repair and since a full understanding of PPG's damages are not complete, the Parish Attorney seeks authorization to file suit against Mr. Cauthron and his insurer for the sole purpose of protecting PPG's interests while the repair proceeds;

## NOW THEREFORE:

BE IT RESOLVED BY THE PLAQUEMINES PARISH COUNCIL THAT the Parish President, through the Parish Attorney's Office, is hereby authorized to pursue the Parish's claim against Thomas Cauthron and his liability insurer, Hartford Accident and Indemnity Company for the full amount of damages owed PPG for the light pole and any other damages. The Parish Attorney is

empowered to file a lawsuit in the 25<sup>th</sup> JDC in prosecution of said damages.

BE IT FURTHER RESOLVED BY THE PLAQUEMINES PARISH COUNCIL THAT the Secretary of this Council hereby authorized and directed to immediately certify and release this Resolution and that Parish employees and officials are authorized to carry out the purpose of this Resolution, both without further reading and approval by the Plaquemines Parish Council.

He also said there was an issue at the old shrimp dock in Venice where someone did boat repairs and spilled 20-30 gallons of old oil. The Parish had to hire a contractor to clean up and the bill was about \$15,000. John Helmers also said the stationary hoist in Venice was repaired and the cost was \$7600. He further stated that they continue to clean and cut grass even with limited manpower. Rob Forshee asked what the breakeven point would be and a discussion was held regarding this matter. Acy Cooper stated that the Venice Marina keeps getting targeted but, they are the only marina with a surplus. He further said that its all the other marinas and harbors that are not making money. Council Member Blink said he does not believe that to be true by the John Helmers' reports. Mr. Helmers ended the discussion by say that we are going to fix this but, it won't be done over night.
