WHEREAS, the term of the agreement shall increase from \$10,000 per month to \$15,000 per month; and

WHEREAS, sufficient funds are available in the current Port Budget;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR & TERMINAL DISTRICT THAT:
