A Resolution authorizing and directing the Port's Executive Director, Charles Tillotson, to enter into and execute a Cooperative Endeavor Agreement (CEA) between the Plaquemines Port Harbor & Terminal District (Port) and Louisiana Department of Transportation and Development (LADOTD) to coordinate grant funding and project management of the Walker Road Bridge project; and otherwise to provide with respect thereto. DIGEST: The purpose of the CEA is for the Port and LADOTD to coordinate project management and grant funding for the Walker Road Bridge project. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*

e. An Ordinance to authorize the Executive Director of the Port, Charles Tillotson to construct a generator bypass for the Port's administration building and to amend the 2025 Plaquemines Port, Harbor and Terminal District Operating Expense Budget; and otherwise to provide respect thereto. (DEFERRED & CARRIED OVER FROM 4-10-25) COMMISSIONER SCHULZ

Digest: The Port must construct a generator bypass to its administration building for redundancy and in case of a generator failure. *The digest is for informational purposes only and is superseded by the language of the actual Ordinance.*

f. An Ordinance to amend the Plaquemines Port, Harbor and Terminal District 2025 Manpower Structure to un-fund the vacant HR Supervisor position and to create and fund one full-time Human Resource Analyst position; and otherwise to provide with respect thereto. COMMISSIONER SCHULZ

DIGEST: An ordinance to amend the 2025 Manpower Structure by un-funding the vacant Supervisor position and creating and funding one full-time Human Resource Analyst position in the General Operations Division. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*

g. An Ordinance to amend the Plaquemines Port, Harbor & Terminal District 2025 Manpower Structure and Operating Expenditure Budget to un-fund the Secretary position in the Ferries Division; and otherwise to provide with respect thereto. COMMISSIONER SCHULZ

DIGEST: An ordinance to amend the 2025 Manpower Structure and Operating Expenditure Budget to un-fund the Secretary position in the Ferries Division. After a review of the Secretary position, the Port wishes to un-fund the position. The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.

h. A Resolution approving and authorizing Chris Schulz, Port Chairman and Charles D. Tillotson, Port Executive Director to execute a Louisiana Compliance Questionnaire to Camnetar and Company, CPA's; and otherwise to provide with respect thereto. COMMISSIONER SCHULZ

DIGEST: The Louisiana Compliance Questionnaire must be executed in order for the Port to stay in compliance. The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.

DIGEST: A Navy Business Case Analysis is needed to continue the growth of the Port and will include an update every five years. This will be a guide to aid Legislators to evaluate the value of these projects as they relate to the State's priorities. An amended budget is required for the project because it was not included in the 2025 Adopted Five-Year Capital Improvements Budget. *The digest is for informational purposes only and is superseded by the language of the actual ordinance or resolution.*
