WHEREAS, Ordinance 25-26 amended the 2025 Five-Year Capital Improvements Budget by appropriating \$128,000 for the M/V Pride Drydock project for the Port's share and \$512,000 for the LADOTD's share increasing the total project by \$640,000; and

WHEREAS, the amended total cost of the project is \$3,290,000 with the LADOTD share projected at \$2,632,000 and the Port's share at \$658,000; and

WHEREAS, amending the Port's 2025 Five-Year Capital Improvements Budget by appropriating an additional \$850,000 from the Port's 2025 Unrestricted Fund to the M/V Pride Drydock Project;

NOW, THEREFORE:

WHEREAS, the change order covers the cost of repairing clutches and exhaust systems; and

WHEREAS, the total cost of the change order increased the project by \$150,000, bringing the overhaul of all four C-18 engines to \$436,000; and

WHEREAS, the proposed change order reflecting this increased scope and cost has been submitted for formal approval, and funding is available within the Rescue Department's approved FY2025 budget;
